Description of Site: The Banks-Vernonia Trail, a multi-use trail paved over a decadesold train bed, allows the walker, jogger, biker or mounted rider the chance to catch a whiff of Oregon history while delighting in the forest's renewed splendor. 21 miles of tree-lined, easy-grade pathway conducts you through sun-dappled glades and across swift, clear streams. The trail surface ranges from six feet wide to eight feet wide, which is paved. Also, one bridge that is just under eight feet wide with no bypass.

It is the largest state park in Oregon with an area of more than 9,000 acres (36 km2), and it includes more than 24 miles (39 km) of walking trails, 14 miles (23 km) of horse trails, and a 4mile (6.4 km) bike path. Its 8.7-mile (14.0 km) Canyon Trail/Trail of Ten Falls runs along the banks of Silver Creek and by ten waterfalls, from which the park received its name. Another 25 miles of wooded, multi-use trails beckon hikers with dogs, horseback riders, trail runners and mountain bikers. These less-traveled backcountry trails wind through lush, native vegetation including salal, sword fern and Oregon grape—all tucked beneath towering second growth stands of Douglas- fir and western hemlock. Access backcountry trails from the North Falls Trailhead, the parking area in the Howard Creek Horse Camp and the Highway 214 trailhead on the southwest end of the park. Open to hikers, bikes and horses. Homestead Trail begins at the Oak Creek Access parking lot. This easy 0.4 mile trail joins the 6021 and 600 roads in making a 1.9 mile loop back to the parking lot. Open to hikers, bikes and horses. Lower Horse Trail travels 0.5 miles through a meadow featuring panoramic views, and connects the 610 and 612.4 roads. Open to hikers, bikes and horses. Upper Horse Trail is a 0.9 mile multiple-use year-round trail and connecting the 610 and the 600 roads. Open to hikers, bikes and horses. Dan's Trail climbs 3.1 miles from 700' at the forest boundary with Chip Ross Park to 1478' at Dimple Hill. Lower Dan's crosses through an historic orchard. Upper Dan's climbs to the top of Dimple Hill for impressive views of Corvallis, the Coast Range, and the Cascade Range. Open to hikers, bikes and horses.

Directions to Site: The easiest trailhead to access the McDonald Forest, on the west edge of Corvallis, is the Oak Creek Area. Follow Oak Creek Drive west from a major intersection of Harrison Boulevard, 53rd Street and Walnut Boulevard.
