Points earned (see chart below) based on placings at the ADS Combined Test events (5) held during the season will determine the winners for each class. In the event of a tie, the lowest accumulated dressage scores will determine the final placings.

### **Black Prong Driving Derby**

Qualifiers: 11/17/22; 12/8/22; 12/29/22; 2/1/23; 3/2/23

Champion, Reserve Champion and Third for all divisions and classes; Prize money

Athletes are eligible to accumulate points at each of the Qualifier Competitions. The top 3 totals will be counted towards the final placing. Competitors must complete at least 2 Derbies. The top 3 Training and top 4 Preliminary athletes in each class will be eligible to compete in the Final Derby Driving Competition, March 29, 2023.

#### **Points:**

Points at each Qualifier (Phase 1) will be awarded in each class as follows:

Athletes are eligible to accumulate points at each of the Qualifier Competitions. The top 3 totals will be counted towards the final placing. The top 3 Training and top 4 Preliminary athletes in each class will be eligible to compete in the Final Derby Driving Competition, March 29, 2023.
