This form must be signed by every competition participant or if a minor, their consenting parent, including each person who rides with a driver on a carriage not only during the actual competition but including any time from arrival at the competition to departure. I understand and agree that neither The American Driving Society, Inc. ("ADS") and its officers, directors, the driving event competition ("Competition"), Competition judges, officials, workers, volunteers or organizing committee nor the property owners accept or shall have any responsibility of any nature whatsoever for accidents, damage, injury or illness to the horses, owners, riders, drivers, grooms, passengers, attendants, spectators or any other person or property in connection with this competition.

I also agree, without any limitation or condition, to hold the ADS, its officers, directors, employees and agents, and Competition judges, officials and organizing committee, harmless from any and all liability, loss, claims or actions, causes of action, judgments or demands of any nature whatsoever. I am fully aware and appreciate that equine sports, including driving in this particular Competition involve inherent dangerous risk of serious injury or death.
