**Description of Site:** With approximately 45 miles of multi-use trails, there are trail activities for everyone including horseback riding, hiking, snowmobiling, cross country skiing, and mountain biking. Mountain biking is allowed on all multiple use trails. A map of these trails is on display at the information kiosks located in the equestrian campgrounds. When using the multi-use trail system: Always call ahead (515)543-8298 for current trail conditions Stay on designated trails only

**Directions to Site:** Equestrian Day Use Staging Area Currently there are two day-use staging areas, one adjacent to North Equine campground and one in the southern portion, near the South Equine campground. Day users are encouraged to use these areas at no charge for the day. Facilities include pit latrine restrooms.

The 13 mile Lake Trail is a wide, mostly gravel loop around Brushy Creek State
Recreation Area Lake. The loop includes some gravel road trekking on the east side but vehicle traffic is very light. The trail is primarily flat with the exception of the south section around the dam. The descent into the creek valley south of the dam is steep and the water crossing here is fairly wide. That said, it's very picturesque and the water is a refreshing resting spot for horses. You can bypass the water crossing by using the road on the dam and rejoin the trail on either side

**Additional services available onsite:** (Camping, water, stabling, etc.) Equestrian Camping Equestrian users enjoy one of the most modern camp facilities in the Midwest. The North Equine campground has a modern shower and restroom, campsites



(including electrical), horse wash area, ample shade, a substantial hitch rail at every site (users are required to tie animals to rails) and a 100' by 200' arena. Water hydrants with potable water are available, as are picnic tables, grills, and a playground. 75% of these campsites can be reserved online through the park reservation system. The rest are available on a first-come, first-serve basis. The South Equine campground has a modern shower and restroom with sites including electric, non-electric sites, and full water and sewer hookup sites with the same amenities as the north campground. Advance campsite reservations can be reserved online through the park reservation system. One fourth of the campsites are still available on a first-come, first-serve basis. Horses are not to be hitched or tied to trees, shrubs or park facilities in a manner that will cause injury or damage to the plant or facility. Animals may be hitched to trailers for short periods of time for grooming and saddling. Animals must be stabled inside a trailer, at a hitch rail or in stalls or corrals if provided. Portable stall/pens or electric fences are not allowed.

**Description of Site:** Use of the 33-mile dirt trail system is open to the public for horseback riding, mountain biking, hiking, and Whiterock Conservancy Gator use (ATV use is prohibited). **Facebook:** <a href="https://www.facebook.com/WhiterockConservancylA/">https://www.facebook.com/WhiterockConservancylA/</a> **Directions to Site:** Arriving from Des Moines: Whiterock is about 70 miles from Des Moines; trip takes about 1 1/4 hours. From I-35/I-80 on the NW corner of Des Moines, exit onto Hwy 141 towards Perry. Drive through Perry, Bagley, and Bayard on Hwy 141. Whiterock Conservancy is 6 miles west of Bayard on Hwy 141. Arriving from Omaha: Whiterock is about 100 miles from Omaha; trip takes about 2 hours. Take I-80 east to Hwy 71 Atlantic/Audubon exit. Go north on Hwy 71, through Audubon, to Hwy 141. Turn east (right) and drive through Dedham and Coon Rapids. Whiterock is located 1 mile east of the convenience store in Coon Rapids on the south side of Hwy 141. Arriving from Ames: Whiterock is about 65 miles from Ames; trip takes about 1 1/4 hours. From I-35 in Ames, go west on Hwy 30. Turn south (left) onto Hwy 25 at Scranton. Turn west (right) on Hwy 141 at Bayard. Whiterock is 6 miles west of Bayard, on Hwy 141.

In addition, fifteen miles of multi-use trails that provide some of the best vistas in Whiterock are open to equestrians. These new trails run through some areas where horseback riders have never been able to ride before. Parking for horse trailers will be available at the River campground and at the new Oak Ridge RV Campground/trailhead. In order to reinforce the soft soils, many parts of the horse trails will have a covering of fine gravel. With use over time, this limestone will mix with the soil to create a longer lasting trail surface. Trail use is \$10 per horse per day to assist with trail maintenance and can be paid at any of the trail heads. Trails close when they are wet. **Description of Site:** Heart of Iowa Nature Trail—Runs parallel to Highway 210 from Slater to Melbourne (Marshall Co.) It is not a continuous trail but you can ride on the crushed limestone trail surface, county roads, and city streets from Slater to Collins (1/4 mile of which is on gravel between Slater and Huxley.) The Heart of Iowa Nature Trail traverses classic Iowa farmland along the former route of the Chicago, Milwaukee, St. Paul & Pacific Railroad, also known as the Milwaukee Road. The trail transitions from smooth crushed limestone in the west to a rougher grass and dirt surface in the east, with a couple of on-road detours

**Directions to Site:** The best trailer parking is available at Slater, Cambridge, Maxwell, Collins, and Rhodes. Huxley's trailhead does not accommodate equestrians; however, water and restroom facilities are available.

Conditions at Site: Rail-to-Trail Horses are allowed on both the developed and undeveloped segments of the trail. On the developed sections, horses should stay on the mowed turf area adjacent to the limestone surface. The best trailer parking is available at Slater, Cambridge, Maxwell, Collins, and Rhodes. Huxley's trailhead does not accommodate equestrians; however, water and restroom facilities are available. Locked gates on some parts to prevent motorized vehicles, key is available from the ranger.

Directions to Site: The Flint Hills Nature Trail has over a dozen conveniently located trail heads and other access points (designated TH on the map), some with nearby parking, camping/lodging, and other trail-friendly services. This list is updated continually, so check back often for the latest developments! Osawatomie — Go 2 miles west on John Brown Hwy (Parker Ave.), and then north on Indianapolis Rd. 1/2 mile. Rantoul — From I-35 east of Ottawa, go east 7 miles. Then south 5 miles on Vermont Rd. Then east (left) on W. Main St. (Rock Creek Rd.) for one block. Ottawa East — Go 1 mile East on 7th St. from US 59 (Main St.) to S. Mason St. Ottawa West — Go 3 blocks West of the Prairie Spirit Trail (which is one block west of Main St.) on First Street, to Maple Street where the trail veers off to the right and passes under 68 Hwy. Pomona — From K-68 at Pomona town, go south one mile on Madison St. (Colorado Rd.) Admire — From US 56, go 1.3 miles south on K-99. Next, go west (right) 2 blocks to Main St. and then south for one block. Bushong — From US 56, go one mile south on Road F. Council Grove East — From Main St. (US 56) go to S. 8th Street. Then go South 2 blocks to Donnon Street and then go West (right) for 2 blocks. Vassar (Gateway to Lake Pomona) — Trailhead is 1 block South of the Vassar Methodist Church on Croco Road.

**Description of Site:** The Glacial Lakes State Trail is located on a former Burlington Northern railroad grade, and is generally level and wheelchair accessible. The trail is paved for 22 miles between Willmar, Spicer, New London, Hawick, and the Kandiyohi/Stearns County line, and a five mile stretch from Richmond to Roscoe is also paved. The many lakes make this area a popular tourist destination. The towns along the trail provide access points, rest stops, and other services to trail users.

**Directions to Site:** Willmar: Take Highway 12 east to County Road 9. Turn north (left) and go two miles to the parking lot on west (left) at the Civic Center. Spicer: At the junction of Highway 23 and County Road 10. Parking lot is west off 23. East Nest Lake Public Water Access: Two miles north of Spicer on Highway 23 and 1/2 mile west on the Township Road. New London: 1 mile northeast of Main Street on County Road 31, at the intersection of River View Lane. Hawick: North side of town, at the intersection of Highway 23 and County Road 2.

**Conditions at Site** 11 miles usable by horses. Horseback riders will enjoy the ten mile stretch of parallel grass treadway from Willmar to New London. From New London to the Kandiyohi/Stearns County line there are grass shoulders for horseback riding.

The park covers 1,280 acres and offers diversity: open prairie knolls, bluffs, and cool, wooded slopes.

Turn left on 67 and go eight miles to park entrances. The first of the park's three entrances will take you to the horse rider campground. The second entrance takes you to the main park entrance. The last entrance takes you to the campground.

**Conditions at Site:** No motorized vehicles are allowed. All of the paths are very well kept and the grassy portions are mowed neatly. Trails are mostly on rolling hills with a few somewhat steep hills as one nears the rivers. Keep in mind that in Minnesota there are bugs in the summer- mosquitos and flies. Come prepared. **Description of Site:** Twenty miles of designated horse trails begin at the horse campground. Located at the north end of the forest on Campground Road, the horse campground's 12 campsites are available on a first-come, first-served basis. This campground is strictly designated for horse camping; general camping is not allowed. The campground includes picnic tables, fire rings, and tethering posts at each site. To use the trails, riders must obtain a day or annual trail pass, available through self registration at the horse campground. A day use or annual vehicle admissions sticker is also required to access the trail and facilities.

**Directions to Site:** The Black River State Forest is located in the heart of west central Wisconsin near the city of Black River Falls. It is approximately two hours southeast of Minneapolis and two hours northwest of Madison near I-94.

**Conditions at Site:** The trails range from wooded and grassy to gravel and sand town roads. Some trail sections are shared with ATVs. Deer fly populations can be heavy in this area and may present a challenge to trail users during the summer months.

**Description of Site:** Equestrians enjoy 39 miles of bridle trail which are traditionally open late April through mid November depending on trail conditions. The main bridle trail winds the linear length of the forest of 33 miles. The southern loop has a wooden bridge to cross at about mile 2, and a steep hill with a sharp bend in the middle at about mile 5. Culverts to cross throughout the park. There is a stretch of gravel road to get to the main trails.

**Description of Site:** Fifty-four miles of equestrian trails offer loops of varying lengths over a cross section of the Kettle Moraine. Riders will enjoy large hardwood forests, pine plantations and many vistas overlooking wet kettles, oak savanna prairies, and area lakes. Horses are limited to trails marked with orange diamonds. A state trail pass is required for riders 16 and older.
