Description of Site: Pachaug State Forest is the largest State Forest in Connecticut encompassing 26,477 acres, in 6 towns -- Voluntown, Sterling, Plainfield, Griswold, North Stonington, and Preston. There are three loops for equestrians that, in addition to yellow diamonds are marked with arrows and mileage. All loops were measured by GPS. All of the loops are marked in both direction. There is a 14 mile, a 7 mile and a 6 mile loop which occasionally overlap. Each of the loops start and end at the Frog Hollow Horse Camp but can also be found and followed from the youth camp. Parking at the youth camp field is allowed in the winter months because the bar gates to the Horse Camp are closed from January 1st to just before opening day of trout season in April. **Directions to Site:** From the South: take I-395 north, Exit 85. Go through the 1st light at the next stop light. Take a right onto Route 138 east. Follow for 9 miles to Voluntown then take a left onto Route 49 north. Forest entrance will be 1 mile ahead on the left. From the North: take I-395 south, Exit 85. At the end of the exit ramp, take a left onto Route 138 east. Follow for 9 miles then take a left onto Route 49 north. Forest entrance will be 1 mile on the left.

Description of Site: The name Natchaug means "land between the rivers" and refers to the land at the junction of the Bigelow and Still Rivers which join to form the Natchaug River. The Forest is popular for its horse trails, outstanding fishing, and riverfront picnic sites. Of historic interest is a large stone fireplace and chimney that are the remains of the birthplace of General Nathaniel Lyon, the first Union General killed in the Civil War. Natchaug was established as a state forest in 1917.

Directions to Site: North on RTE 97 off RTE 6 in Hampton. Go through Hampton Center, pass elementary school on right, LEFT at fork onto Station Rd. (appears straight as 97 curves right). Go approx 1.5 mi. (you will pass Airline Trail barway, go up hill and road takes hard L becoming Morey Rd.) Take gravel road on right (unmarked) into Natchaug Forest. Bear LEFT at T (Kingsbury Rd) (unmarked) then RIGHT to the Silvermine Horse camp.

For horses you need to tie to trailer, picket line or put portable fence on site.

Large commercial carriages from the concession also use this ramp so check tour scheduling if you want to avoid having to pass them with your private horse and carriage, as some horses are frightened by the bigger rigs. Bubble Pond path is one way only...make sure you approach it from the correct direction.

Directions to Site: From Boston take I-95 north to Augusta, Maine, then Route 3 east to Ellsworth and on to Mount Desert Island, HEIGHT RESTRICTIONS APPLY! Check your route before entering park to be sure your trailer will fit under bridges. There are essentially three different ways to get to Wildwood Stables. One is from Bar Harbor via the one-way section of the Park Loop Road. There is a turn-off on the right just before reaching the part of the road that changes to the one-way. If you miss this, there is a second entry point immediately after on the right as well. You may also get to this point from the Cadillac Mountain and Jordan Pond side of the road by heading south. Look for the entry point on the left. The third way is from Seal Harbor. Take the Stanley Road on the opposite side of the road from the public beach and head North. Turn left on the Park Loop Road and take an immediate right for Wildwood Stables. Refer to the Acadia map for location information. The stables are operated by a private business concessionaire on park land. Reservations are strongly advised and are usually accepted up to one week in advance. Directions to Site: To get there, take exit 14 from Mass. Route 495. Head north on Route 1 to your second intersection, Thurston Street. From there follow the state forest signs to forest headquarters or park at either of the two metal state forest gates that will be on your left. THIS PARKING LOT OFTEN FULL ON WEEKENDS Fair warning... the parking lot at forest headquarters is usually filled on weekends. It's best to try and park somewhere else. Another good place to park, and the site of the future main parking lot for the forest, is about another 1/2 mile north of Thurston Street on Route 1. Just after Myrtle Street on your left look for a small paved road on your right. This is High Rock Road. The new parking area will be located right near Route 1. You can park there now or you can follow High Rock Road to the top of the hill where there is a large parking area near a communications tower. By parking here you will avoid the dirt road section that returns you to forest headquarters, and also most of the forest's other trail users. High Rock Road is also a much better place to park on weekends, mornings and evenings when the gate at forest headquarters will be locked.

Description of Site: 20 miles of trails Pond Walk - 2.9 mi. of unpaved carriage road. Trailhead: Begin at the Park's Main Entrance Lat/Long: 42.062441, -71.166414 Distance: 3.0 miles, Difficulty: Easy Brief Description: Follow the carriage road leading around Lower Leach Pond. This beautiful trail is mostly wooded. You will pass the picturesque stone lodge, foundations, dam and bridge, open fields, the 1910 Ames Mansion and the picnic grounds.

Directions to Site: Borderland is located approximately three miles from the center of Sharon, Mansfield and North Easton, MA. The park is twenty miles from Boston and thirty miles from Providence, RI. From north: Take Rte. 128 south to Rte. 95 south (towards Providence). Take exit 10 (Sharon, Walpole and Coney Street). Take a left at the end of the ramp and follow this road, two or three miles to the traffic lights in Sharon Center. Go straight thru this intersection and immediately bear right onto Pond St. Follow Pond St. for 1-1/2 miles until you come to a traffic rotary. Go half way around the rotary and continue onto Massapoag Ave. for three miles to the park entrance, on your left. From Boston: Take the southeast expressway south to Rte. 128 north and then to Rte. 95 south. Follow directions from above. From West: Mass Pike to Rte. 495 south to exit 10 (Easton and Rte. 123). Take a left at the end of the ramp and follow Rte. 123 east towards Easton. Rte. 123 will merge with Rte. 106 east. After this merge look for the brown "Borderland" sign, on the left about a half mile from the merge. Take this left onto Poquanticut Ave. After about a mile the road will fork, bear to the left onto Massapoag Ave. and follow the signs to the park, approximately another two miles. Entrance will be on your right.

Description of Site: Starting from the Machimoodus SP parking lot; At the end of the parking lot is a map board. Travel past the map board along the old gravel road and along a causeway between two ponds. Picnic tables located here. Continue straight at the intersection along the Lower Vista Trail. You'll head downhill into the woods coming to a sharp curve and narrow dirt path on your right at 0.3 miles. This path leads into the Sunrise Resort State Park. Note: Spur to Overlook; Before heading into the Sunrise Resort SP, continue along the gravel road. The road splits at 0.7 miles, keep left. You'll pass by a small pond and travel past a large field before coming to a circle with picnic tables at 1 mile. The Salmon River Cove is down below. The views were obstructed by the trees but I imagine in the Spring & Fall you would have clear views of the river. The narrow dirt path by the sign post is the entrance for the Upper Vista Trail. Heading right follow the narrow dirt path through a stone wall where the trail widens as you enter a Pine forest. Follow the Blue Trail straight to an intersection. Head left along the Blue Trail. Cross over a wooden bridge and head left on the gravel road alongside a large field. Spot some of the old building foundations from the resort. You'll come to a parking lot at 0.9 miles. Head left out to the old paved road. Spot the old basketball courts across the road. Turn left and follow the paved road down a steep hill. Caution; Watch out for road erosion. This brings you down alongside the Salmon River at 1.2 miles. Popular stopping point for canoes & kayaks. Continue straight along the river as the road ascends up a steep switchback to an intersection. Head left and you'll soon pass by the old tennis courts and ball field before passing through a parking lot and coming to an intersection. Head left, passing by the old resort buildings and you'll come to a gate at 1.8 miles. Follow the old entrance road straight past a turnoff to Route 151 and you'll



come to another gate. Head past the gate along a gravel road and you'll return to the Machimoodus SP parking lot after a 2 mile loop.

Directions to Site: From the junction of Routes 66 & 151 in Cobalt follow Route 151 south for 6.6 miles to the park entrance on the right. OR From the intersection of Routes 82 and 149 in East Haddam follow Route 149 north 3.8 miles to its intersection with Route 151.
